The meeting was called to order at 6:05 pm by the Moderator, Elder Yvonne Armstrong and opened with prayer offered by Elder Armstrong..

Constituting the Meeting

The Stated Clerk reported that a quorum is present consisting of at least 25 minister members and 25 elder commissioners representing not less than 20 congregations. Requests for excused absences have been received from 9 minister members and 5 elders or elder commissioners. **M/S/A to dispense with the reading of the names of persons requesting excused absences, which will be reflected in the attendance record, (Appendix I) and to honor the requests for excused absences along with any received today by email, voicemail or regular mail.**

Election of Docket Clerks

M/S/A to elect the following members as Docket Clerks, Rev. Josephine Cameron, Elder David Michel, Rev. Krystin Granberg, Elder Choon Whe Cho.

Approval of the Docket

Rev. Edmonds reminded everyone that this is a called meeting and that the only items that will be addressed are those listed on the docket. **M/S/A to approve the docket**

Seating of Corresponding Members

M/S/A to seat for this meeting Rev. Choi, Korean United Presbyterian Church, and Rev. Gilbert Sherman, United Church of Christ, as corresponding members.

The Stated Clerk reported that the meeting is constituted

Address by Executive Presbyter

The Rev. Arabella Meadows-Rogers addressed the Presbytery and spoke about the joys of her six years of service with the Presbytery. She spoke of the question, "what is our mission and what does God want of us?"

The Report of General Council

Rev. Perry Wooten, presented the Report of General Council.

The General Council met on June 9, 2009 and the Executive Presbyter, Rev. Arabella Meadows-Rogers submitted her resignation, effective October 31, 2009, due to health issues. The final day of active

service will be July 31, 2009. Rev. Meadows-Rogers has served the Presbytery for over six years with diligence, compassion, love and professionalism in spite of the enormous medical difficulties she has faced. Considering the challenges which Rev. Meadows-Rogers faces in the future, and deeply appreciating her concern that she will not be able to give the same degree of commitment and time to the business of the Presbytery that she has in the past, the General Council presents the following recommendations to Presbytery for approval:

Moved, that the resignation of Rev. Arabella Meadows-Rogers be accepted with regret, effective October 31, 2009, and that the period between August 1 and October 31 be considered vacation, sick leave, personal and study time accrued, and that, therefore, full compensation, benefits and parking privileges continue until the end of October.

For ease of handling the moderator divided the motion into two parts:

M/S/A, that the resignation of Rev. Arabella Meadows-Rogers be accepted with regret, effective October 31, 2009.

Moved, that the period between August 1 and October 31 be considered vacation, sick leave, personal and study time accrued, and that, therefore, full compensation, benefits and parking privileges continue until the end of October.

- It was asked if the same consideration would be extended to all executive staff. It was explained that all of the above mentioned was time that was accrued and that the same would apply to another individual provided that it was the same circumstance.

Vote taken by ballot, Motion Approved: 130 In Favor - 7 Against

Moved, that Rev. Meadows-Rogers receive a gift payable on December 31, 2009 equal to the amount of the full compensation and benefits calculated from November 1, to December 31, 2009.

- It was asked, where would the money come from to provide Rev. Meadows-Rogers with a gift? It was reported that the Board of Trustees met and decided that the money would come from the endowment.

M/S/A to call the question. Vote taken by ballot. Motion Approved: 131 In Favor - 17 Against

Moved, that an Interim Executive Presbyter Search Committee be established by a committee comprised of the Moderator, Elder Yvonne Armstrong, the Moderator-Elect, Rev. J. Perry Wootten, the Chair of General Council, Rev. Margaret Orr Thomas, the Chair of the Personnel Committee, Elder Ian Amritt, and two additional members of the Personnel Committee, Elder Sara Jenoure and Elder Lynda Spielman. The Acting Executive Presbyter will serve as advisory staff.

M/S to Refer item 3 back to General Council for clarification to be returned to the Presbytery for action at its next regular meeting. M/S/A to call the question. Motion to Refer is Defeated

M/S to Amend the Main Motion by adding a final sentence. "And that the committee elected to seek an Executive Presbyter only to seek a candidate outside of New York City Presbytery."

Motion Defeated

M/S/A to Amend the Main Motion to read as follows: "That an interim Executive Search Committee be nominated to the Presbytery *composed* of the Moderator, Elder Yvonne Armstrong, the Moderator-Elect, Rev. Perry Wootten, the Chair of General Council, Rev. Margaret Orr Thomas, the Chair of the Personnel Committee, Elder Ian Amritt, and two additional members of

the Personnel Committee, Elder Sara Jenoure and Elder Lynda Spielman. The Acting Executive Presbyter will serve as advisory staff.

M/S/A the Amended Motion, that an Interim Executive Presbyter Search Committee be established by a committee comprised of the Moderator, Elder Yvonne Armstrong, the Moderator-Elect, Rev. J. Perry Wootten, the Chair of General Council, Rev. Margaret Orr Thomas, the Chair of the Personnel Committee, Elder Ian Amritt, and two additional members of the Personnel Committee, Elder Sara Jenoure and Elder Lynda Spielman. The Acting Executive Presbyter will serve as advisory staff.

Moved, that the Presbytery of New York City employ, as Acting Executive Presbyter, the Rev. Dr. Oscar McCloud beginning August 1, 2009 and continuing until the election of an Interim Executive Presbyter, under the following terms:

Term

The Acting Executive Presbyter is a short-term, full-time position to bridge the period between the Executive Presbyter's departure and the hiring of an Interim Executive. It is expected to continue for approximately six months.

Responsibilities

The Acting EP will have all the responsibilities of an Executive as listed in the attached job description.

Accountability

The Acting EP is called and employed by the Presbytery and is accountable to the body for the implementation of its decisions.

Remuneration

\$125,000 annualized

One month vacation annualized

Two weeks study leave annualized and \$1000 for study leave expenses

Reimbursement for professional expenses, including parking at 475 RSD or The Riverside Church but not travel to and from work.

Other benefits (health, pension) to be worked out in conversation with the applicant depending on his/her circumstances. The policies of the Personnel Manual (full medical coverage and pension benefits) will be applied to the applicant's circumstances.

- It was asked, where and the dollar amount associated with this position will come from? It was reported that the Acting EP's salary for this year would come from the endowment and next years salary would come from the 2010 budget.

Vote taken by ballot, Motion Approved: 126 In Favor - 17 Against, 2 ballots were not counted.

Rev. McCloud thanked the Presbytery for having confidence in him to do the job. He would like for the Presbytery to help him in determining what work needs to be done.

M/S/A to Adjourn. Meeting adjourned at 8:00 p.m., with prayer offered by the Rev. Arabella Meadows-Rogers.
